Government Affairs Report: 1/28/25 General Membership Meeting at Peekskill YC:

BRIDGE REPLACMENT IN ALBANY: Up in Albany, the Livingston Avenue railroad swing bridge is scheduled to be replaced with a lift bridge and a new walkway to be included. Navigation channel closure to take place 1/16/27 to 1/29/27. Additional 30-day restricted navigation channel 1/30/27-3/1/27. Other than the 2-week closure, an 84-foot minimum channel will be maintained. Air draft minimum should stay at 25-feet. These dates likely to change.

SEDIMENT ISSUES: In the Annual Hudson River Estuary Management Advisory Committee letter to NYS DEC commissioner Shawn Mahar included the following copy, based on our many clubs need for maintenance dredging:

Sediment Management: Sediment in the Hudson Estuary is complicated, with more sediment needed to shore up tidal wetlands against sea-level rise, but some removal is needed to maintain access for commercial and recreational boating....There is no clear solution to this longstanding and complex issue, but there are a number of stakeholders clearly identifying the need for establishing a framework to guide, and funding to support, responsible sediment management.

PCB CLEAN UP: The EPA finalized their 3rd, five-year review of the PCB cleanup of the Upper Hudson, and says while "levels of PCB's are going down overall, but more fish (PCB sampling) data is needed." EPA believes it needs 8 years of data after upper Hudson dredging, which comes due this year, 2025. However, now it won't be until 2027 before EPA releases their 3rd, five-year review determination. EPA says the science tells them they cannot make a determination now on how the clean up is working. Environmental groups strenuously disagree, say the data is here today, and wanted EPA to issue a 5 year review without delay. Again, this focus is the upper river. For us on the lower river, you may recall some a sampling program has begun. No news on that for now.

PCBS ON FLOODPLAINS: In related news the Citizen Advisory Group for the Hudson River Superfund site met and discussed PCB floodplain contamination in the upper Hudson. One term used was "flood mud." 75 areas have inspected with some receiving short-term actions – mitigation designed to cover affected areas, such as with stone. These areas require maintenance against scour. This mitigation is designed as temporary. Total area is more than 6,000 acres in the river flood plain. Expected to take 10 years. Property owners want permanent fixes. Concern that people – kids- are going through these shoreline areas. Since beginning effort, 1,959 properties have been evaluated. If you navigate up there this summer, please be aware of areas you may see shoreline mitigation taking place and to proceed no wake.

CANCEL A CABLE: The 175-mile Clean Path NY, which was designed to take renewable energy from parts of NY state down to New York City has been cancelled. The on-going CHPE cable project (to bring power from Canada to NYC) will be giving the Hudson River Safety Navigation Operations Committee and update on Feb 10. We will share at next meeting.

ICE ICE BABY: The USCG reported on the 2024-2025 Ice Season. So far so good – channel is being successfully maintained to Albany.


